<p>Areas of application</p>	<p>Microl SR 010 is a combination of inorganic acids, used in micro filter- and ultra filter systems to remove inorganic residues from the membranes.</p> <p>Microl SR 010 is especially developed to remove residues, caused by the water e.g. carbonates.</p> <p>Microl SR 010 is able to remove the residues in a very short time of application.</p>
<p>Method of application</p>	<p>Re-circulating cleaning system:</p> <p>Concentration: 1.0 – 5.0 % Temperature: cold – 30°C Time: 5 – 10 minutes</p> <p>After having used the product rinse thoroughly with drinking water to remove any possible residues!</p>
<p>Material compatibility</p>	<p>PVDF, PP, PE, PVC, Stainless Steel, Glass, and membranes suitable for alkaline and acid cleaning solutions.</p> <p>Microl SR 010 must not be used on steel and cast iron and membranes made from cellulose and cellulose acetate.</p> <p>In addition, further material incompatibilities cannot be excluded. Therefore, test the product before use and ask the producer of the membrane if the product is compatible with the product.</p>
